A. Administrative fees

When signing the contract with DNS LU, the agent (futur registrar) has to pay the amount of 500 euro (excl. tax) for the right DNS-LU grants it to participate in the administrative procedure to register domain names. This is a one-time, non-refundable fee. This fee covers administrative expenses, particularly expenses related to setting up an account with DNS-LU, expenses related to a possible technical aptitude test, and expenses for the registration software, including subsequent updates.

B. List of applicable fees charged to the registrar for registering and administering .LU domain names

The registration, renewal, transfer of management to another registrar, trade (change of ownership), reinstatement of domain names in redemption, as well as the unsuccessful outcome of some transactions are subject to the payment of certain fees. These fees are in respect with real costs incurred.

1. The registration fee charged per domain name is 12 euro (excl. taxes) or 13,80 euro (incl. 15% VAT) at the date of signature of the registry-registrar contract. This fee covers the registration of a domain name for a term of one year starting on the date when the registrar receives confirmation from DNS-LU that the name was duly registered.

2. Each registration is, in principle, automatically renewed for a one-year period each time it expires. The corresponding renewal fees is 12 euro (excl. taxes) or 13,80 euro (incl. 15% VAT) per domain name.

3. Each transfer of management of a domain name to a new registrar (called transfer), is considered as a new registration for the benefit of the new registrar and subject to the payment of relevant fees as stated under point 1) payable by the new registrar.

4. The unsuccessful outcome of a transfer is charged at 3,00 euro (excl. taxes) or 3,45 euro (incl. 15% VAT) per domain name to cover administrative expenses. This fee is payable by the registrar having initiated the transaction.

5. Each change of ownership of a domain name (called trade), is considered as a new registration for the benefit of the registrar and subject to the payment of relevant fees as stated under point 1), payable by the registrar of the new domain name holder.

6. The unsuccessful outcome of a trade is charged at 3,00 euro (excl. taxes) or 3,45 euro (incl. 15% VAT) per domain name to cover administrative expenses. This fee is payable by the registrar having initiated the transaction.

7. When reinstating a domain name in redemption, a fee of 24,00 euro per domain name (excl. taxes) or 27,60 euro (incl. 15% VAT) is charged. This fee includes the registration fee for the beginning of a new one-year registration period. This fee is also due in case of a simultaneous transfer to a new registrar. Names in redemption may only be reinstated during a period of 30 days.

C. Currency

Only bank wire transfers in euro are accepted. DNS-LU will not bear any bank charges. No cheques are accepted.
